The meeting commenced with recitation of Holy Quran by vice chairman, Mr Chayya, after that the Chairman in his opening remarks, stressed the need of making APSAA a formidable force, he also appreciated hard work of Maj (R) Munir and his team to get APSAA recognized at all forums of Government, the recent example is our fight for relief in WHT, which was appreciated by no lesser person the Prime Minister and Finance Minister. It was decided to send a letter to member companies, to explain the new system. The Chairman also asked tax committee to arrange meeting with zonal Income Tax commissioners so that all are on one page, he recommended same for North Zone through senior vice chairman Col (R) Tiwana. The chairman also directed all sub committees chairman's to work on the tasks assigned to them as committee chairman. The chairman also asked Maj (R) Munir, Col (R) Taugir and Mr Chayya to arrange interaction/ meetings with high officials of Government who concerns private security companies. Senior Vice Chairman, Col (R) Jalil Tiwana will form similar committees in North Zone.

- 4. <u>Non Issuance of Weapons License</u>. Problems of non issuance of weapon licenses to members was discussed in detail. The chairman, decided to discuss this problem with DG Ranges for supposedly the ban on issuance of new licenses to members is on his advice. The problem will be discussed with commissioner Karachi also, in monthly meeting.
- 5. <u>Increase In Visits by ISI, MI & Other Agencies Representative</u>. Col (R) Tauqir-ul-Islam apprised the committee that different persons claiming to belong to ISI, MI and counter terrorism etc, without proving their identity are pressurizing members to give irrelevant (to them) data, like audited accounts, account number of directors, their cell numbers and list of clients etc. It was ruled by the Chairman that these persons should not be given any such data and they be given his (Chairman's) number to talk to him. In the mean time he will discuss this with DG Rangers and commanders of intelligence agencies.

- 6. **Approval of New Membership**. Request for new membership of following security companies was approved by EC.
 - a. Ellahi's Security Services (Pvt.) Ltd.
 - b. Silver Arrows Security Services (Pvt.) Ltd.
 - c. Territorial Guards Pakistan (Pvt.) Ltd.
- 7. **School Renovation.** On request of principal ATS, the EC approved Rs. 35000/- (Rs. Thirty Five Thousand Only) for repair / renovation of ATS. Mr. Imran will supervise the work and confirm.
- 8. <u>Ammunition in Bulk from WAH Ordinance Factory</u>. Chairman informed that he had already met and after that as decided written to Chairman POF Wah for issue of weapons and ammunition to APSAA for further purchase by the members.
- 9. **Return of Cheques to Members**. The EC decided to return cheques of Rs. 25000/- (Rs. Twenty five Thousand Only) contributed by members towards lawyers fee for WHT issue to those members who donated with thanks. The same was not utilized by APSAA. Similarly due to poor response by members towards contribution for help of earthquake victims, the cheques of worthy members who donated were also allowed to be returned to them (cheques have been returned).
- 10. **Expenditure On WHT Campaign**. It was decided that amount spent on campaign to get relief from 8% WHT be distributed on all members. Same is being done which comes to Rs. 7021/- (Rs. Seven Thousand and Twenty One Only) per member. Members are requested to pay their share immediately.
- 11. <u>Seminars</u>. Capt (R) Muhammad Abid was given the special task to arrange seminars, in consultation with Chairman, at the scale of at least one per quarter. The aim was to educate everyone regarding Private Security and provide the business of PSA level playing fields to operate in view of the proliferation of semi Govt PSAs eg Bahria, Askari, Rangers, Police, FC etc.
- 12. Since there was no other point on agenda hence the meeting concluded with vote of thanks to chairman.
