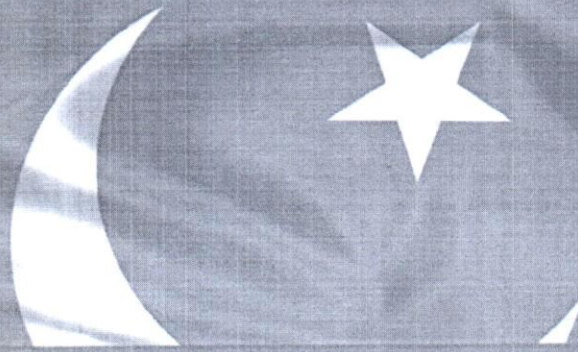

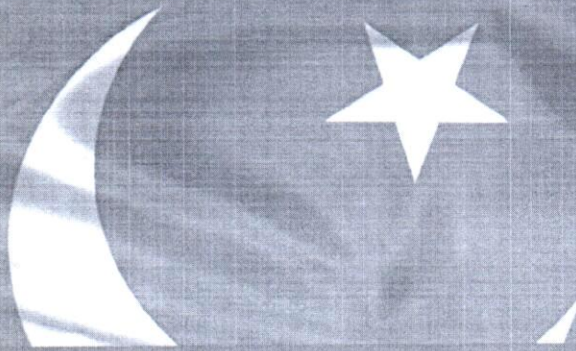
- ☐ Provisional Voters list will be displayed on APSAA Website and APSAA Notice Board on 17<sup>th</sup> July 2017.
