- 2. Home Department Government of Balochistan shall consider the issuance of certificate to allow the operations of your Company in the Province of Balochistan as a Private Security Company, in the areas of cash-in-transit in armoured cars for Banks/Business concerns, Courier Services for valuables, documents, provision of static guard services, etc. for industrial/business concerns subject to the terms of undertaking given by your Company on fulfilling the following terms and conditions duly executed:-
 - I) That M/s. _____ (hereinafter referred to as "the Company/Agency" shall not render any service to the following:
 - a) Autonomous Bodies
 - b) Provincial Government
 - c) Ministries
 - d) Any Government Agency
 - e) Sensitive Key Points
 - II) The Company/Agency shall remain subject to:
 - a) Apply to the Home Department, Government of Balochistan, for such registration stating therein that the Company/Agency shall establish their Provincial office in the territorial limits of the Province from where all operations in the Province will be controlled.

- b) The application by the Company/Agency for registration should be submitted along with necessary credentials such as:-
 - Names addresses and background of owners/directors/management of the agency.
 - ii) Work and task already being performed by the Company/Agency at various places in Pakistan and since how long.
 - iii) Financial position of the agency, (Bank statement verifying financial and other assets to be attached) and,
 - iv) List of field staff to be employed and deployed by the Company/Agency in Balochistan along with their credentials and complete information of identity.
- c) All field staff of such agencies to be employed/deployed in Balochistan will have to be cleared by the Special Branch, prior to their deployment; in case of ex-servicemen, ex-ASF or ex-CAF employees clearance will be obtained from the Federal Government, Interior Division. No registration/NOC will be granted without such clearance.
- d) The conditions and restrictions laid down by the Interior Division shall be fully observed and the required undertaking shall be furnished by the applicant Company/Agency.
- e) On grant of registration/NOC to a Company, such Company/Agency shall operate in the Province in the mode prescribed as under:
 - i) It will be mandatory of a Company/Agency to, keep the Home Department, Government of Balochistan informed about any agreement concluded with a client and as well as to the District Magistrate and Superintendent of Police of the concerned district.

- ii) Further, such agency shall be required to inform local Police Station or Levies Thana about the place of their operation and full particulars of the staff employed, the weapons issued/used and the nature and extent of their obligation under intimation to the District Magistrate and the Superintendent of Police concerned.
- iii) Any change or variation in this regard shall also be reported promptly to the local Police/Levies Station.
- iv) The Magistrate concerned and the Police/Levies shall have the right to carry necessary checks as they are authorized in the case of chowkidari system, at any time.
- III. The Security Company/Agency shall submit the list of their employees to the Federal/Provincial Government with particulars as under:
 - a) Name
 - b) Father's Name
 - c) National Identity Card (two attested copies)
 - d) Permanent Address
 - e) Present Address
 - f) Bio-data with full particulars
 - g) Copies of certificates (two attested copies)
- IV. If any employee of the Company/Agency is involved in theft, dacoity, robbery/murder, treason or anti-state activities, etc (the Company/Agency shall be held jointly and variously responsible and shall be liable to any legal action to be taken for it by the competent authority and the sanctioning authority shall have a vested right to cancel its sanction.
- V. The Security Company/Agency shall approach the Ministry of Interior, Government of Pakistan, for getting the pattern of uniform of their employees approved.
- VI. Quarterly reports indicating full general activities of the Company/Agency shall regularly be sent to the Home Department, Government of Balochistan.

- VII. The Security Company/Agency shall follow the laws/rules, policy and instructions on the subject as and when framed by the Government and that the Company/Agency shall conduct its operations in accordance with such directions that the Provincial Government may issue from time to time to regulate and control their working.
- VIII. A fee of Rs. 100,000/= is fixed for registration of the Private Security Companies. This fee would be in addition to the fee levied by SECP (Securities and Exchange Commission of Pakistan), if any.
- IX. An amount of Rs. 250,000/= shall be deposited by the Private Security Companies before issuance of NOC as security deposit which shall be refunded at the time of winding up of the Company.
- X. NOC issued to Private Security Companies shall be renewed after every two years on the basis of their performance. Renewal fee @ Rs. 10,000/= would be charged from each company in respect of their operations/renewal of their NOC in the Province.
- XI. NOC of those Private Security Companies/Agencies whose performance was not found satisfactory would be cancelled forthwith.
- XII. Private Security Company shall give an undertaking to the effect that they shall not transfer/hand over/sub-let the Company to any other person/party in any form.
- XIII. The Private Security Company/Agency must get itself registered with Employees Old-Age Benefits Institution (EOBI) as per law and provide a copy of Registration Certificate.
- XIV. The Private Security Company/Agency shall provide 'No Demand Certificate' from the Income Tax to Ministry of Interior on annual basis under intimation to this Department.
- XV. Uniform of the Private Security Company shall be distinguishable from any law enforcement, military and para-military agencies and that the full name of the private security company shall be written on the chest of the shirt.
- XVI. The Home Department, Government of Balochistan shall have the right to withdraw the No Objection Certificate at any time without assigning any reason.
