Subject: - **Blacklisting of Security Supervisor and Security Guards**

Dear Sir,

PPS would like to bring into your kind knowledge and record that one of our Security Supervisors, Lutf Ali Shaikh, working in Karachi Office along with 18x Security Guards (particulars of all attached as Annexure "A") have been terminated from service with immediate effect, on account of charges as elaborated below: -

## **Security Supervisor Lutf Ali Shaikh**

1. Guilty of misappropriation in salary amount given to him for disbursement to security guards.
2. Fake claiming of advance salary on behalf of guards.
3. Selling of company's issued uniform items.

To counter the above malpractices, we started Bank to Bank transactions for the guards on all kind of disbursements and uniform was also distributed to the guards by bringing in dedicated staff.

Once the doors of misappropriation of funds and stealing started closing on supervisor Lutf Ali, retaliated by misguiding the guards for non-adherence of orders etc., under his supervision. On receiving several complaints, we removed supervisor Lutf Ali from field duty on 13 November, 2023 (Monday) and instructed him to join the office for various administrative tasks. Instead of reporting to the office, supervisor Lutf Ali removed 18 guards from different bank branches being guarded by Parwest on 14 November, 2023 morning from their place of duties.

By the Grace of ALLAH Almighty, we were very lucky to control this situation by posting reserve guards from our pool and a catastrophic situation was averted.

In view of forgoing and to ensure non-repetition of such like situation in future, PPS strongly recommend blacklisting of security supervisor and the security guards and the same be disseminated to different Police departments and Security Companies registered with your esteemed office. We would also like to seek your kind support and guidance for a stern legal action by registering a criminal FIR against supervisor Lutf Ali.

This will not only serve as a deterrence for avoiding such type of situations in future but will also be a source of comfort for all APSAA Companies.
