SUBJECT:- INCREASE IN VIOLENCE BY SECURITY GUARDS.

It is submitted that in recent months increase in violence / unnecessary aggression from the Private Security Guards has been noticed by this Zone. In most recent incident on 25.02.2025, a man namely Waleed s/o Arif Shamim aged 35 was shot killed by the security guard after a verbal altercation in the area of North Nazimabad. FIR of instant matter was registered in PS North Nazimabad vide No. 88/2026 u/s 302 PPC. Prior to that during year 2025, security guards were found involve in 03 incidents during which a child aged 04 years and boy aged 24 years were shot dead in area of PS Manghopir & Sh. Noor Jahan respectively. While during June-2024 a YouTuber namely Saad Ahmed, was shot dead by guard at Sarina Mobile Market area of PS Taimuria.

These incidents clearly reflects that the Security Guard companies miserably failed to provide necessary training to security guards before deployment, on the other hand during the interrogation of arrested security guards, their mental health was not satisfactory.

Therefore, it is recommended that the necessary correspondence may kindly be initiated with quarter concerned to ensure proper training of security guards and conduct their psychiatric tests, before deployment. While it is also recommended that SOPs for hiring, training & deployment of security guards should be chalked-out and implemented to avoid such incidents in future.
